Grant of Options

Safestay (AIM: SSTY), the owner and operator of a brand of contemporary hostels, announces that on 30 June 2021 it granted awards of options over a total of 62,700 ordinary shares of 1 pence each in the Company ("Ordinary Shares") under the Company's existing share option scheme (the "Options") to five Directors or persons discharging managerial responsibilities ("PDMR").

The Options are exercisable at a price of 18 pence after a period of one year from the date of grant and were awarded in lieu of a 40% reduction of salary in the month of June, as previously announced on 13 October 2020.
